Call to Order:

The Board meeting was called to order by President James Kelly at 6:35 p.m. at 27900 Robinson Rd.

Presentation of Service Awards and Recognition:

President James Kelly and Fire Chief Robert Hudson presented an Engineer/Operator Certificate to David Evans.

To consider and approve minutes from prior meeting(s):

Commissioner Rodney Otto made a motion to accept the minutes from the April 6, 2015 meeting. Commissioner John Rodriguez seconded the motion. The motion passed with a vote of five (5) FOR and zero (0) AGAINST.

To review and take action on District 2013 – 2014 Audit

John Watson presented the final audit to the Board with no concerns.

Commissioner Rodney Otto made a motion to accept the audit as presented. Commissioner George Biernesser seconded the motion. The motion passed with a vote of five (5) FOR and zero (0) AGAINST.

Note: District Attorney Howard Katz addressed the Board stating that the District Attorney council has not received or looked at the audit.

To receive Treasurer's report.

Kaye Townley of Municipal Accounts provided a detailed review of the Bookkeeper's report to the Board.

Attorney Howard Katz addressed the Board suggesting listing Texas Class and the CDARS program as agenda items to discuss money markets.

To review and act on any Resolution(s) to designate and authorize Municipal Accounts to execute wire transfers, open and close Certificates of Deposit by telephone/fax/email.

Consider and approve payment of accounts

Commissioner Rodney Otto made a motion to approve payment of accounts. Commissioner George Biernesser seconded the motion. The motion passed with a vote of five (5) FOR and zero (0) AGAINST.

Commissioner Rodney Otto left the Board meeting at 7:10.

Discuss and take action on granting exemptions for 2015.

The Board postponed agenda item 12 to enable research on previous minutes.

The Board revisited agenda item 12 at 7:30.

Commissioner Andy Walters made a motion to change the current homestead exemption from 6% to 10% and over 65 years of age to \$25,000 and Disability to \$25,000. Commissioner John Rodriguez seconded the motion. The motion passed with a vote of four (4) FOR and zero (0) AGAINST.

To discuss and take action on the ratification of a continuing Contract with Linebarger Goggan Blair & Sampson, LLP for the collection of delinquent District ad valorem property taxes, and providing for the payment of 20% of the delinquent taxes, penalties, and interest which are collected by the attorney under said Contract.

President James Kelly presented the contract to the Board. District Attorney Howard Katz communicated the delinquencies to the Board. Commissioner Andy Walters made a motion to ratify continuing contract. Commissioner George Biernesser seconded the motion. The motion passed with a vote of four (4) FOR and zero (0) AGAINST.

To discuss and take action on the imposition of additional penalty on delinquent taxes for 2014 pursuant to Section 33.07 of the Property Tax Code and adoption of a Resolution regarding same.

President James Kelly opened the discussion to the Board. District Attorney Howard Katz defined the accounts to the Board. Commissioner George Biernesser made a motion to adopt 14, 15, and 16. Commissioner Andy Walters seconded the motion. The motion passed with a vote of four (4) FOR and zero (0) AGAINST.

To discuss and take action on the imposition of additional penalty on delinquent taxes for 2014 to defray costs of collection by the District's delinquent tax attorney, pursuant to Section 33.08 of the Property Tax Code and adoption of a Resolution regarding same.

To discuss and take action on the purchase of a cargo trailer for fire prevention utilizing a citizen donation

Chief Hudson addressed the Board suggesting using donations for the purchase of a 12x6x6 trailer from TX Trailer Supply. Commissioner Andy Walters made a motion to purchase a trailer as presented. Commissioner John Rodriguez seconded the motion. The motion passed with a vote of four (4) FOR and zero (0) AGAINST.

To discuss and take action on items pertaining to new Station 11-3, Robinson Road, including report from architect, pay applications, change orders or any other related matters.
