

MONTGOMERY COUNTY EMERGENCY SERVICES DISTRICT #8 BOARD MEETING August 02, 2021

The Board meeting was called to order by President James Kelly at 5:30 p.m. at 27900 Robinson Rd.

Presentation of Recognitions, Certificates for Promotions and Appointments

Three members, E/O Joe Stan, E/O Tommy Solesby, and Lt. Wes Baker, were recognized with a Service Award for ten-years of service as members of South County Fire. E/O Joe Stan and Lt. Wes Baker were presented their award by Chief Hudson and James Kelly. E/O Tommy Solesby was unable to attend.

Consider and approve the Minutes from prior meeting(s).

Commissioner Rodney Otto made a motion to accept the minutes as presented for the July 19th, 2021 meeting. Commissioner Leah Gray seconded the motion. The motion passed with a vote of five (5) FOR and zero (0) AGAINST.

Consider and approve payment of accounts.

Commissioner Leah Gray made a motion to approve payment of accounts, and to allow President James Kelly and Commissioner Rodney Otto to sign any checks necessary prior to the August 23, 2021 meeting. Commissioner Justin Hill seconded the motion. The motion passed with of five (5) FOR and zero (0) AGAINST.

Discuss and act on the District's budget for FY 2021-2022

Commissioner Rodney Otto and Chief Hudson presented the draft budget to the Board. Discussion followed regarding how the process occurred this year as well as the challenges in the upcoming fiscal year. No action was taken, and the final draft will be presented for adoption at the meeting scheduled for August 23, 2021.

Discuss and act on proposing the District's 2021 ad valorem tax rate.

The Board reviewed a document presented by District's legal counsel with five options with regard to setting the tax rate for 2021. After discussion regarding the options, Commissioner Rodney Otto made a motion to approve the De Minimis tax rate for 2021. Commissioner Justin Hill seconded the motion. The motion passed with a vote of five (5) FOR and zero (0) AGAINST.

Discuss and act on scheduling a public hearing regarding the District's 2021 ad valorem tax rate and the date of the meeting to adopt

Commissioner Leah Gray made the motion to schedule the Public Hearing on the 2021 tax rate on August 23, 2021 at 5:30PM. Commissioner Misty Perrine seconded the motion. The motion passed with a vote of five (5) FOR and zero (0) AGAINST.

Review and act on matters relating to calling an election to be held on November 2, 2021:

- a. Approve an Order calling for an election under Texas Tax Code Section 26.07.
- b. To review and act to hold an election jointly with other jurisdictions.
- c. To review and act to contract with Montgomery County Elections Office for election services.
- d. To consider and act on such other Orders, Resolutions, and related matters as required or appropriate to call for the District election.

Commissioner Rodney Otto made a motion to approve payment application #8 for Station 11-5 for \$269,010.63. Commissioner Misty Perinne seconded the motion. The motion passed with a vote of five (5) FOR and zero (0) AGAINST.
