Commissioner Hill called the meeting to order at 5:30 pm at 27900 Robinson Road.

Review and act on personnel matters:

Commissioner Perinne made a motion as follows:

The board has determined the Local Government Code Chapter 177a does not remove firefighters from the workers' compensation system, but the case of Firefighter Corby McKenzie is an extraordinary situation.

Based upon the review of material presented by staff in closed session and consultation with legal counsel, the Board finds that Firefighter Corby McKenzie has suffered an illness related to Firefighter McKenzie's line of duty as a firefighter. Therefore, the Board orders that he be provided a leave of absence under Local Government Code section 177A.003. The Board further orders that Chief Koteras and staff use an average of Firefighter McKenzie's prior two full years of normal duty hours to determine the amount to be paid to

him and that he be provided his full retirement, health insurance, and other standard benefits. Commissioner Rodriguez seconded the motion. The motion passed with a 5-0 voice vote.

Commissioner Perinne motioned to approve the service agreement proposal from Ezee Fiber. Commissioner Rodriguez seconded the motion. The motion passed with a 5-0 voice vote.
