 - b. Statement of existing District policy.
 - c. Direction to place an item on a future District Agenda.

6. To review and act on financial matters including financial report, investments, depository institutions, depository security agreements, audits, Investment Policy, District bills.

8. Review and act on the Interlocal Agreement with MCHD for VHF Simulcast Communications.
9. Review and act on the MOU with the MCFCA for engaging into a VHF Simulcast Interlocal Agreement with MCHD
10. Review and act on the proposal from Metro Fire to purchase (13) 4-gas meters, 2 docking stations, and 4 calibration bottles.
