  - b. Statement of existing District policy.
  - c. Direction to place an item on a future District Agenda.

5. Consider and approve the Minutes from prior meeting(s).
6. To review and act on financial matters including financial report, investments, depository institutions, depository security agreements, audits, Investment Policy, District bills.
7. Review and act on the agreement with Marriott Cityplace for the annual member appreciation banquet.
8. Receive list of District property marked for disposal per Policy P-061 and Chapter 775 of the Health and Safety Code.
9. Receive report from the District's Fire Chief or designee.
