 - b. Statement of existing District policy.
 - c. Direction to place an item on a future District Agenda.

6. To review and act on financial matters including financial report, investments, depository institutions, depository security agreements, audits, Investment Policy, District bills.

9. Receive list of District property marked for disposal per Policy P-061 and Chapter 775 of the Health and Safety Code.
