Each person may offer comments for items on the posted meeting agenda for a period of two to four minutes, depending on the number of persons who have signed up to speak. Each person may offer comments for items not on the posted meeting agenda for a period of one to two minutes, depending on the number of persons who have signed up to speak. Comments by Commissioners in response to such citizen comments shall be limited to:
 - a. Statements of specific facts in response to an inquiry.
 - b. Statement of existing District policy.
 - c. Direction to place an item on a future District Agenda.
4. Presentation of Recognitions, Certificates for Promotions and Appointments.
5. Consider and approve the Minutes from prior meeting(s).
6. To review and act on financial matters including financial report, investments, depository institutions, depository security agreements, audits, Investment Policy, District bills.
7. Review and act on accepting the FY 2024-2025 District audit
8. Review and act on granting property tax exemptions for 2026.
9. Review and act on the renewal agreement with First Due.
10. Review and act on the proposal from Multicopter for \$12,724.40 for the purchase of a Drone for Preparedness Division.
11. Receive list of District property marked for disposal per Policy P-061 and Chapter 775 of the Health and Safety Code.
12. Receive report from the District's Fire Chief or designee.
13. Receive and act on report from the Construction Committee on ongoing construction projects.
14. Review and discuss the installation of traffic control measures for Station 11-3, including possible cooperation with Montgomery County for same.
